

Description of Activities and Acts for Adult Performer Audition

The audition process for adult performers may involve participation in specific activities designed to assess your comfort level, professionalism, and compatibility with the company's production requirements. Below is a detailed breakdown of potential activities. Participation in any act is entirely voluntary, and you may opt out of any part of the audition at any time.

1. Interview and Consent Discussion

Before any physical activities begin, there will be a thorough discussion to:

- Confirm your understanding of the audition process.
 - Establish clear boundaries regarding the types of acts you are comfortable performing.
 - Review legal documentation, including age verification and signed consent.
 - Discuss safe practices, including STI testing protocols and protective measures.

2. Non-Explicit Performance Assessment (*Optional*)

- **Body Modeling:** Posing in different outfits, lingerie, or nude to evaluate your comfort with on-camera nudity and body confidence.
 - **Acting/Role-Play:** Performing scripted or improvisational scenes to assess your acting skills and ability to take direction.
 - **Interviews on Camera:** Speaking directly to the camera to gauge your on-screen presence and ability to engage with the audience.

3. Explicit Performance Evaluation (*Optional and Fully Consent-Based*)

- **Simulated Acts:** Engaging in non-contact simulations of explicit acts to demonstrate confidence, body language, and understanding of production requirements. Examples include:
 - Suggestive poses.
 - Simulated intimacy or foreplay without physical contact.
 - **Solo Performance:**
 - Participation in a solo scene to demonstrate comfort and skill in performing explicit acts on camera.
 - Use of personal items, such as toys, may be included, depending on consent.
 - **Partnered Performance (*if mutually agreed upon*):**
 - Participation in a scene with a pre-approved partner to assess chemistry, professionalism, and adherence to consent protocols.
 - Acts may include:
 - Kissing or other intimate gestures.
 - Simulated or explicit sexual acts, including oral or penetrative acts, as agreed upon.
 - All interactions will be preceded by clear communication of boundaries and safe practices.

4. Use of Safe Practices

- **Protective Measures:** barriers, and other safety tools will be provided and condoms will be used if required for the scene.
 - **Breaks and Check-Ins:** Regular breaks and consent check-ins will occur throughout the audition to ensure ongoing comfort.

5. Final Review

- At the end of the audition, there will be a debrief to discuss your experience and any concerns you may have.
 - You will have the opportunity to ask questions and provide feedback.

Important Notes:

- You may stop or withdraw consent for any activity at any time, with no penalty or obligation to continue.
- All acts performed during the audition will remain confidential and will not be distributed or shared without your explicit written consent.
- A chaperone or trusted individual may be present during the audition if requested by you.

By signing the audition consent form, you affirm that you have been informed of these activities and agree to participate only within your boundaries and comfort levels.
